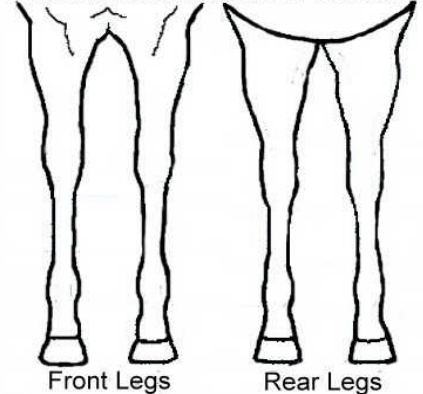

DNA has become the industry standard for all credible registries. Some show circuits, such as International Friesian Show Horse Association (IFSHA), require DNA before you can show. It is important to know that there is no test to determine if a horse is of a particular breed. Therefore, comparing DNA from an offspring to its parent(s) is the only valid way to determine ancestry. It is essential to maintain unbroken DNA links, through the generations, in order to preserve and authenticate a bloodline. Beware of registries that DNA test without parent verification. DNA markers alone, without the parent verification, cannot substantiate lineage.

K DNA PARENT VERIFICATION REQUIREMENTS

HH strongly recommends that all horses of Friesian Heritage be DNA tested at the time of registration, so it can be noted on the registration certificate. When a horse has been DNA tested, "On File" will be written on their papers. When they have not been DNA tested, "Not on File" will be written on their papers. Although DNA is not required for all horses at this time, it is required for Purebred Friesians and breeding horses.

◆ **Purebred Friesians:** Must be DNA tested with HH **OR** registered and DNA tested with another credible Friesian registry **OR** you may supply us with a copy of existing DNA markers.

◆ **Sires & Dams:** All breeding horses of Friesian ancestry, who are registered with HH, must have DNA on file with HH, before their offspring can be registered with HH.

Note: In order to conduct parent verification tests, a \$15 DNA conversion fee may be required for any horses DNA tested at any lab other than UC Davis.
