TRANSFERRING FROM ANOTHER REGISTRY

- ◆ **Print Clearly & Include All Items** If items or information is missing, or illegible, your papers will be delayed and office fees added.
- ◆ **Original Registration Papers** Send original certificate (not a copy) from the registry that you are transferring from.
- ◆ **Photos Required** Three close photos that clearly show all markings. RIGHT and LEFT sides (including feet), and one close-up of the FACE from the front, with the forelock pulled to the side. When possible, please provide photos of the Sire and Dam and a newborn photo. **Photo requirements can be waived, if prohibited by religion.**
 - **PHOTOS BY EMAIL (Preferred):** Send to PIX@FriesianHeritage.com Horse's first choice name **MUST BE** in the subject line.
 - **PHOTOS BY MAIL: MUST BE** of good quality and have the name of the horse written on them.
- ◆ **Hair Sample-Required** A hair sample is required for each application. There is no fee for this, unless DNA testing is ordered.
- ◆ **Proof of Ownership** If the current owner is not listed on the submitted papers as "owner", then proof of ownership or transfer must be provided, i.e., a copy of a bill of sale, breeder signatures or transfer form of some type, signed by owner listed on papers.
