◆ **Pedigrees & DNA of Parents** Enclose a copy of the sire and dam's registration papers, unless you know they are already on file with GHH.

For Gypsy sires & dams, who are not already on file with the GHH, please obtain DNA markers from their Gypsy registry and send a copy with this form.

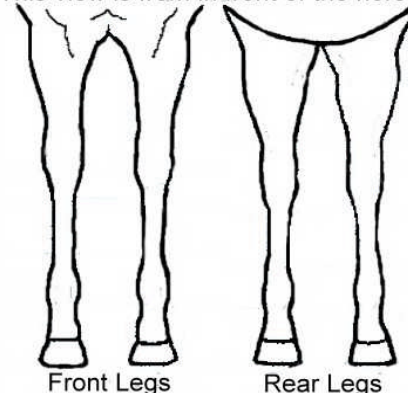

DNA has become the industry standard for all credible registries. Some show circuits, such as International Friesian Show Horse Association (IFSHA), require DNA before you can show. It is important to know that there is no test to determine if a horse is of a particular breed. Therefore, comparing DNA from an offspring to its parent(s) is the only valid way to determine ancestry. It is essential to maintain unbroken DNA links, through the generations, in order to preserve and authenticate a bloodline. Beware of registries that DNA test without parent verification. DNA markers alone, without the parent verification, cannot substantiate lineage.

J DNA PARENT VERIFICATION REQUIREMENTS

Sires & Dams: Must be DNA tested with HH OR registered and DNA tested with another **credible registry**. We can accept copies of existing DNA parentage markers from most registries.

Please choose one of the following:

- My horse does not have DNA markers. Please perform the required DNA marker/parentage verification that is included with registration. A laminated copy of the results will be mailed, at the same time as the registration certificate.
- Horse has been previously DNA tested through UC Davis and I am supplying a copy of the markers and/or case number: _____
- Horse has been previously DNA tested through a lab other than UC Davis and I am supplying a copy of the markers **and I am including the \$2000 conversion fee.**

Note: In order to conduct parent verification tests, a \$2000 conversion fee may be required for any horses DNA tested at any lab other than UC Davis. In some cases, a conversion fee(s) may also be required on the sire and/or dam of horse being registered. All hair submitted becomes the property of HH.
